




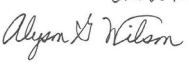

**SUBJECT:** Artificial Intelligence (AI) Advisory Group, AI and Business Operations Subgroup Charge

**DATE:** October 17, 2024

The Artificial Intelligence (AI) Advisory Group received its charge in April of this year outlining two subgroups to carry out the charge. After its first meeting it was quickly determined by administration and the committee that there is a substantial overlap between the issues arising from university business uses of AI in research and teaching. Therefore it was decided that a third subgroup would need to be formed under the AI Advisory Group. In addition to advising the Executive Vice Chancellor and Provost and the Vice Chancellor for Research and Innovation, this third subgroup will be advisory to the Executive Vice Chancellor for Finance and Administration and the Vice Chancellor for Information Technology and focused on business and administrative uses of AI. This subgroup will:

- Focus on security and compliance issues arising from business uses of AI;
- Develop and publish clear guidance for policy decisions around privacy and security in use of generative AI tools in the course of doing university business;
- Recommend techniques and tools for ensuring data privacy and confidentiality in AI applications;
- Foster communities of practice to share ideas for using AI to advance efficiency and productivity;
- Explore possible uses of AI to gain insights into university data; and
- Address other questions of interest and importance to the university

Mardecia Bell has agreed to serve as the subgroup leader. We appreciate your willingness to serve as members of the advisory group.
