WELCOME AND INTRODUCTIONS

- Remarks from Chair Welcomed the committee members and guests and discussed postponing the chair elect decision until later in the semester to give people time to decide.
- Remarks from OUCCAS/DASA-Li welcomed the committee and informed the committee that the topic outline should be fixed. Graduate level courses do not need a topic outline, but undergrad and dual level courses do. The instructor is required for dual level and graduate level courses, but not undergraduate level courses.

FS 492 External Learning Experience - Approved Pending with Suggestions

Discussion: The new course was presented by Melissa Merrill. Member asked about the contact hours for learning experience and asked if the contact hours should be 3:10, but the committee confirmed the contact/credit hours are correct. The catalog description is different from the description in the syllabus.

Melissa Merrill moved to amend the motion from approved to approved pending the inclusion of the catalog description. Members brought up the video production requirements in FS 492 and 493 that the video quality needs to be high quality and suggested that adding information about a video shot on a phone would suffice and that a rubric can be helpful to qualify what a high quality video would be. Members agreed this information could be kept in the syllabus, not in the CIM form.

> FS 493 Research Experience in Food Science - Approved Pending with Suggestions

Discussion: The course was presented by Melissa Merrill.

Member asked why there was a \$20 liability insurance fee and asked if the course is taught on campus why there would be an insurance fee and pointed out the confusion that the course is on campus, but maybe taught as an internship as well. Members asked if there should be an additional statement in the justification that the insurance fee is for external use only instead of the on campus.

Motion to amend the motion from approved to approved pending (approved with one nay from Melissa Merrill) to include the information in the justification standpoint. Member from R&R indicated the internship liability insurance is \$12, not \$20 for the year and confirmed with the cashiers' office.

Members brought up the video production requirements in FS 492 and 493 that the video quality needs to be high quality and suggested that adding information about a video shot on a phone would suffice and that a rubric can be helpful to qualify what a high quality video would be. Members agreed this information could be kept in the syllabus, not in the CIM form.

Member made a suggestion to elongate the abbreviated title to utilize the available characters since this is what will

display on students' transcripts.

Suggestion to correct the syllabus to sophomore standing, or remove the restrictive statement in the syllabus.

The Department of Health and Exercise Studies offers a 16 credit hour Dance Minor that is designed for students who wish to delve deeper into dance studies in an intellectual, creative, and practical capacity to propel them forward in career, service, and artistry. The coursework is balanced between theory courses, creative inquiry, and technical proficiency. The student has the opportunity to select the specific courses which best fulfill his/her needs while maintaining an overall balance. A student in the dance minor may be preparing for graduate study or for work as a performer, choreographer, educator, or dance therapist. The

dance minor also enhances students' studies as they prepare for careers and service as arts entrepreneurs or administrators, physical therapists, physicians, or in disciplines such as Africana studies, design, film, and engineering.

- 7. Requirements for Completion of the Minor

The dance minor requires the completion of 16 credit hours.

Students must obtain a grade of "C-" or better in each of the required and elective courses.

Students may not take minor coursework on a credit only (pass/fail) or S/U basis.

Students must attain a minimum overall GPA of 2.0 in the minor.

The program coordinator will certify the minor prior to graduation.

A minimum of 12 of the 16 required credit hours must be completed at NC State.

No change is necessary for either the SIS plan code or the subplan code. The prefix "WGS" can refer to Women's, Gender, and Sexuality Studies.

Reason for the title change

In the last 5-10 years, many campuses have been having important discussions about how to rename programs in Women's Studies to reflect the interdisciplinary and critical nature of the scholarship and pedagogy in the field. At NC State, students and faculty have been similarly engaged in discussions of the possibilities for how our program name can accurately reflect the scope and depth of what we do. Faculty and students agree that changing the name of the Women's and Gender Studies subplan reflects alignment with the recent, but significant, evolution in the field of Women's Studies. Most undergraduate programs in Women's Studies in the United States have altered their names to include the terms "feminist," "gender," and/or "sexuality."

For example, current program names at other North Carolina schools include:

- · Women's, Gender, and Sexuality Studies at UNC Greensboro
- Gender, Women's, and Sexuality Studies at Appalachian State
- Gender and Sexuality Studies at Davidson
- Gender, Sexuality, and Feminist Studies at Duke

Recent name changes reflect an evolution in the scholarship of Women's Studies towards a more expansive understanding of gender identity that recognizes gender across a range of identities and expressions, including complexifying what has been understood as male/female difference, and better attending to the experiences of intersex, transgender and gender non-conforming individuals. The field that was historically known as "Women's Studies" or "Women's and Gender Studies" is broadening to include sexuality as a significant organizing concept, especially because of the multiple overlaps and continuities between sexuality studies and gender studies. Recent name changes also reflect an evolution towards intersectional feminism, a set of theoretical approaches to analyzing social inequality that are more nuanced in their understanding of multiple differences, including differences based on race, class, sexual orientation, ability, and more. Programs are evolving to better center Black feminist and Womanist theory, as well as other theoretical approaches to gender studies and feminism that arise from and center BIPOC (Black, Indigenous, and People of Color) experiences. With all of these developments, what seems most significant is to signal an intentional shift away from an exclusive focus on the concerns of white middle class heterosexual women, which is often how Women's Studies programs born in the "second wave" of feminism have operated and been perceived. The name change is meant to reflect substantive changes in the scholarship and interests of scholars and students.

Informal conversations with students at NC State over the past few years have indicated that many of them no longer believe the name "Women's and Gender Studies" fully represents the substance of their academic pursuits. With this in mind, we conducted an informal survey of some of the core WGS faculty and WGS majors and minors in early March 2020 to find out their preferences about changing the name of the program. The survey was sent to all WGS majors and minors (50 students total at the time of survey) and the WGS executive committee (9 faculty total). We received 24 responses (17 students, 7 faculty).

The survey used a Google form and asked respondents whether they preferred to keep or change the current name of WGS and to rate their preferences on a scale of 1 to 5 for the following name change options:

- Women's, Gender, and Sexuality Studies
- Gender, Sexuality, and Feminist Studies
- Gender and Sexuality Studies
- Gender Studies
- · Women, Gender, and Sexuality

The strongest positive response was for "Women's, Gender, and Sexuality Studies," with a rating of 3.79 for students and faculty combined, and a rating of 3.86 by faculty only. Most respondents preferred to change rather than keep the current name.

The survey also asked the open-ended question, "If you feel strongly in favor (or opposed) to any of the suggested options, please share your reasons," which solicited the following responses from students/faculty:

"On the one hand I think that whatever name is chosen should reflect "women" or "feminist" because it acknowledges that the study is rooted in a long history of feminist movements. However, I understand that feminism can be exclusionary and has treated certain groups poorly, so I guess I have an open mind about it."

"I think that making the name more so about gender in a broader sense (rather than just "women's") allows for less misconceptions about the program (we hate men, only talk about women) and helps to center folks outside of the binary."

"I would really love to see sexuality included in the name. With elements of sexuality in every WGS class I've taken it seems to be an essential part of the field."

We believe that changing the name of the subplan to Women's, Gender, and Sexuality Studies will better reflect the content of our courses, including the newly approved courses, WGS 390 Queer Theory and WGS 380 Black Feminist Theory. It also better represents the work of students who choose to pursue a focus on sexuality studies within the WGS major. There is also anecdotal evidence to suggest that changing the name of Women's and Gender Studies to Women's, Gender, and Sexuality Studies will help with recruiting new majors and minors.


