### WELCOME AND INTRODUCTIONS

- **Remarks from Chair Elect Renee Harrington** – Due to Chair Kanton Reynolds being late (arrival: 1:35pm), Renee welcomed the committee and handed over time to OUCCAS. Renee also welcomed the guests following Darby Orcutt's presentation.
- **Remarks from OUCCAS/DASA** – Li made remarks about two additions to the end of the agenda. Li reminded the committee that on March 3, 2023 there will be an email sent out about a GEP special topics update. Lexi commented on two upcoming training sessions being offered in March as well as announcing weekly office hours for OUCCAS.
- **Approval of the UCCC Minutes from 8 February 2023** – *Approved*  
Discussion: Members moved to properly approve the previous meeting minutes. No remarks/comments were shared.
- **Presentation by Darby Orcutt** – CUE Chair and NCSU Libraries faculty member Darby Orcutt gave a brief presentation about integration of Cambridge University Press textbook access, which is currently being previewed.

### OLD BUSINESS

- **ANS 241 : Introduction to Meat and Poultry Processing** – *Approved with Suggestions*  
Discussion: This new course was presented by Park. Reviewer expressed concern about the animal science/poultry science crossover and consultation thereof. Reviewer also suggested that the necessity for an absence excuse note in the field trip section be removed. Member expressed concern about the requirement for a sixteenth week for finals week content (presentation, paper, etc.). Members discussed the lack of clarity regarding whether or not the sixteenth week should be a week reserved for final evaluations and Li stated she would follow up with research on that topic. Members moved forward to approve the course with suggestions to remove the absence note from the field trip section.
- **ANS 241A : Introduction to Meat and Poultry Processing** – *Approved*  
Discussion: This new course was presented by Park. Presenter clarified this is the parallel course connected with the AgInstitution 2-year program. No further comments were shared.
- **ANS 242 : Value Added Meat and Poultry Processing** – *Approved with Suggestions*  
Discussion: This new course was presented by Park. Members moved forward to approve the course with suggestions to remove the excuse note from the field trip section (last sentence in the description of the field trip within additional information).

- **ANS 242A : Value Added Meat and Poultry Processing – Approved**  
Discussion: This new course was presented by Park. Presenter clarified this is the parallel course connected with the AgInstitution 2-year program. No further comments were shared.

## NEW BUSINESS

- **Consent Agenda - Approved**  
Discussion: Members moved to approve and properly second the consent agenda. No remarks/comments were shared.
- **HI 462 : Southern History since the Civil War – Approved Pending with Suggestion**  
Discussion: This course was presented by Croasmun. Reviewer made a friendly suggestion regarding “3 hours of history” and asked for clarification on what is meant by “history” in the prerequisites. Members discussed the assessment and members moved to approved pending clarification on assessments regarding how the SEM is stated as “Other” at 100%; members requested this be revisited and completed appropriately.
- **IS 250 : Globalizing North Carolina – Approved**  
Discussion: This course was presented by Croasmun. Reviewers commented on the complexity of the SLOs and whether or not that needs further clarification and review regarding the evaluation process. Other reviewers complimented the complexity of the SLOs. Member commented on the topic outline and asked about week or week ranges (something that was reiterated as being mentioned before regarding requirements vs best practices and week ranges). Members move to approve without any further comments/suggestions.
- **STS 310 : Science, Psi, Sasquatch, & Spirits – Approved with Suggestions**  
Discussion: This new course was presented by Croasmun. Members complimented the course also stating “this is the weirdest course I have ever reviewed”. Member commented on the third SLO stating that there are two discrete cognitive actions but one objective (regarding double-barreled SLO confusion in the past). Guest/instructor of the course Darby Orcutt stated that he would be happy to split the objective into two, but the assignment will be a single assignment. Motion to approve with a friendly suggestion to adjust the third SLO.
- **Economics (BS) - International Partner Business School (IPBS) - Incoming – Approved**  
Discussion: This curricular action was presented by Morant. Members commented on the “incoming”; guest and director of global programs at PCOM briefly and concisely explained the difference between incoming and outgoing in regards to the IPBS “incoming” title.
- **ST 451 : Sports Analytics – Approved Pending**  
Discussion: This new course was presented by Duggins. The presenter moved to approve pending due to the fact that the syllabus has not yet been approved. Member also suggested adding to the approved pending motion: revisiting potentially “double-barrelled” SLOs and splitting them into relevant individual SLOs rather than using a conjunction to combine multiple cognitive evaluation verbs. Formatting adjustments and adjustments to the time ranges/assessments were also part of friendly suggestions.
- **Biological Sciences (BS): Integrative Physiology and Neurobiology Concentration – Approved**  
Discussion: This curricular action was presented by Duggins.
- **Physics (BS): Interdisciplinary Physics – Approved with Suggestions**  
Discussion: This curricular action was presented by Jones. Reviewer suggested moving ENG 101 and the next section to be aligned with the rest of the appropriate formatting. No further comments/remarks were shared.
- **Zoology (BS) – Approved with Suggestion.**  
Discussion: This curricular action was presented by Jones. Member commented on the display of the plan requirements - there appears to be a missing footnote. Friendly suggestion to consider consistency between the footnotes.
- **TMS 212 : Yarn and Fabric Formation and Properties – Approved**  
Discussion: This course was presented by Krause. Presenter clarified that this course had undergone a cleanup and was tabled over a year ago. No further comments/remarks were shared.

- **DAN 120 : Movement Improvisation – Approved with Suggestions**

Discussion: This course was presented by Harrington. Members noticed the word “cumulation” in the third SLO and wondered if it should be “culmination” so suggested revisiting that for clarity purposes.

- **DAN 230 : The Horton Dance Technique and Legacy – Approved**

Discussion: This course was presented by Harrington. No comments/remarks were shared.

- **DAN 272 : Dance Composition - Solo Forms – Approved**

Discussion: This course was presented by Koch. No comments/remarks were shared.

- **MUS 106 : Beginning Piano – Approved**

Discussion: This course was presented by Koch. No comments/remarks were shared.

Discussion: Kanton thanked Renee for standing in for him and thanked the committee for their time.
