- > Remarks from Chair Ghada Rabah Chair welcomed the members and introduced Dr. Mike Mullen.
- Remarks from Vice Chancellor and Dean, Dr. Mike Mullen- Introduced himself and thanked the committee for their important work with GEP. The taskforce for the U.S. Diversity was established and reached a decision last summer in response to the concerns expressed at the town hall meetings about not having a credit requirement for U.S. Diversity. The last report after being presented and discussed at the faculty senate meeting in an effort to keep the 39 required GEP hours from going over. There were various recommendations that will be reviewed and CUE will likely be presented and asked for feedback in January.


Review GEP



Request to add FAC CHAIR DEPT seat to CUE and fill it for the 2017-18 academic year

To: The Committee on Committees

The University Courses and Curricula Committee (UCCC) Chair serves as a non-voting member during committee proceedings in order to maintain impartiality and to represent the committee's work as a whole. Currently, when a new UCCC Chair comes into service, the Committee on Committees assigns a faculty member from the Chair's college to a one-year FAC CHAIR DEPT seat to maintain the same number of voting members from that college.

The election of a new Chair of the Council on Undergraduate Education (CUE) also vacates a voting seat for the Chair's college. As some colleges have one representative and some have two, this causes colleges to either not be represented on CUE or to be under-represented.

As such and after consultation with CUE members, we respectfully request: That a FAC CHAIR DEPT seat be added to the CUE roster for a one-year term seat, similar to the UCCC configuration.
