WELCOME AND INTRODUCTIONS

- > Remarks from Chair Darby Orcutt Warm welcomes given to members by the chair. Guests introduced.
- Remarks and Updates from OUCCAS/DASA Thanks given by Li Marcus to the committee and OUCCAS staff during her absence.
- Approval of the CUE Minutes from 4 March 2022 Approved Discussion: Minutes were approved unanimously with correction to spelling in several places.

OLD BUSINESS

ANT 481 / ANT 581 : Zooarchaeology (SS) – Approved

Discussion: This new course was presented by David Berube. This course was previously tabled by CUE on January 21st, 2022 in regards to needing more measurable terms and outcomes in the SLO section. A reviewer commented that the course now contains the proper criteria.

Consent Agenda - Approved

Discussion: The consent agenda was approved unanimously without any discussion from members.

Courses New to GEP

> HS 275 : Floral Design (VPA) - Approved

Discussion: This new course was presented by Carrie Pickworth on behalf of Jenny Xiang. Reviewer pointed members towards Objective 2 and Outcome 2 to confirm alignment. The other reviewers confirmed alignment after a brief exchange.

Approved Unanimously

HESF 120: Movement and Meditation (HES) – Approved Pending

Discussion: This new course was presented by Peggy Domingue. The first reviewer provided positive feedback about the course. The second review had a question regarding objective 3. The learning outcome did not appear to list the proper skill measures that should be expected, rather just serving more as an information statement. The third reviewer shared this concern. A guest confirmed that she was looking more a skillset and competencies, and proposed adding an additional measure, due to the complexity in connecting the learning of motor skills, and the technical details of motor skills. The committee suggested adding a line such as 'the skills are performed and videoed for instructor feedback' to the measure of the objective. Third review also suggested to remove the word 'discuss' from objective 3.

Since the changes will be made immediately, the committee chose to approve outright, rather than pending the course.

► HON 356 : Sweet: A Global History of Sugar (GK, IP) – Approved

Discussion: This new course was presented by Peggy Domingue. The first review thought the course meets the expectations for both GEP categories. The second review had no concerns with the course and gave positive comments.

Review Courses for GEP

➤ HESM 324 U.S. Concert Dance History (USDEI, USD) – Approved

Discussion: This course was presented by Peggy Domingue. The first reviewer thought everything met alignment and supported the minor changes made to USD. The USDEI category is well aligned. Other members provided positive feedback.

MUS/WGS 360 Women in Music (USDEI, USD, VPA) – Approved Pending with Suggestions

Discussion: This course was presented by Peggy Domingue. The first reviewer had two concerns, the first under USDEI. The second objective has no measurement listed. The second concern is under VPA, the reviewer wanted member's thoughts on how the objective is being met. OUCCAS believes the lack of measurement under USDEI may be broken. Upon revealing what the measurement says, the Chair suggested removing the word 'often'. A reviewer wanted to see a stronger link between the processes and inequalities described in the objective. The VPA concern was in regards to objective 3, the question being how are sounds associated with certain cultural norms? A guest answered the question which resolved the concern.
