### WELCOME AND INTRODUCTIONS

- ❖ **Remarks from Chair Darby Orcutt** – Darby welcomed everyone and requested that guests introduce themselves. Christa Gala introduced herself. Darby explained his role as the Assistant Head of Collections and Research Strategy with NCSU Libraries and discussed some information about working with Cambridge University Press.
- ❖ **Remarks and Updates from OUCCAS/DASA** – Lexi yielded OUCCAS time to Kaitlyn Mittan for a presentation
- ❖ **Presentation from Kaitlyn Mittan from OAA** - Kaitlyn provided information about the two QEPs from OAA: Packways for All and Transfer Student Success Center. Kaitlyn also discussed the workflow for assessment of academic programs as well as upcoming reaffirmation milestones.
- ❖ **Approval of the CUE Minutes from 3 February 2023** – *Approved*  
Discussion: Members moved to approve the minutes from the last CUE meeting. No remarks/comments were shared.

### OLD BUSINESS

#### Special Topics/HON Course Offerings

- **IPGK 295 “The Struggle of the Free Press: Fake News & Conspiracy Theories” (IP, GK) – *Approved with Suggestions***  
Discussion: This course was presented by Reaser. Darby explained the previous meeting’s review and why the course returned to the committee, particularly with regard to the specifics of the interdisciplinary nature of the course. Members moved to approve the course. Reviewers stated that the clarity was improved. Reviewers suggested an edit on a typo on Objective #1 as well as an edit to IP Objective #3 to add “while” in between the words “media” and “creating”. There was also a suggestion to remove the additional questions from the first outcome.

### NEW BUSINESS

#### USDEI Review Effective 2023

- **DAN 230 : The Horton Dance Technique and Legacy (VPA, USDEI) – *Approved***  
Discussion: This course was presented by Belk. Reviewers complimented the course. No further remarks/comments were shared.

#### Courses New to GEP

- **FLN 351 : Hindi-Urdu Popular Culture (HUM, GK) – *Approved***  
Discussion: This new course was presented by Reaser. No remarks/comments were shared.

Review Courses for GEP

- **DAN 120 : Movement Improvisation (VPA) – Approved**

Discussion: This course was presented by Belk. Reviewers complimented the course. No further remarks/comments were shared.

- **DAN 272 : Dance Composition - Solo Forms (VPA) – Approved**

Discussion: This course was presented by Belk. Reviewer asked about how in Objective #1 and Objective #2 (regarding how “discuss” would be evaluated) and suggestions were made to specify “graded discussion” rather than just “discussion” in Objective #1 and Objective #2. Members discussed what it means to specify “graded discussion” and members felt it was not necessary to maintain this suggestion. Members moved to approve without any suggestions.
