Review Courses for GEP

- **BIO 440 : The Human Animal: An Evolutionary Perspective (USDEI)** – *Approved*
Discussion: This course was presented by Lubischer. Reviewers complimented the thorough nature of the measures of the outcomes. No further remarks/comments were shared.

Special Topics/HON Course Offerings

- **NSGE 295 Environmental Change (NS)** – *Approved*
Discussion: This course was presented by Opperman. Member asked if the course would go up for full approval at some point and requested suggestions for areas needed to clear up for what to do when the course goes up for formal full review. Reviewers complimented the course and its contents. One reviewer had some concerns about clarity, but these were not specific to the course and were more to do with their new role as a proxy reviewer.
