WELCOME AND INTRODUCTIONS

- **Remarks from Chair Marta Klesath** – Chair welcomed the committee and handed over announcements to Li.
- **Remarks and Updates from OUCCAS/DASA** – Two training sessions are offered on Monday, February 3: CIM Lab with Lexi and a FAD workshop with Li and Logan.

Discussion: No further discussion was shared.

NEW BUSINESS

Courses New To GEP

- **MUS 340 : From Wax Cylinders to AI: Music Technology in Modern History (HUM, IP)** – *Approved*
Discussion: This new HON course was presented by Fath. Instructor Kristen Paige was present. No further discussion was shared.
- **HON 370 : Contemporary British Voices (IP, GK)** – *Approved*
Discussion: This new HON course was presented by Fath. Reviewers discussed a few suggestions pertaining to interpretation and then retracted each of the suggestions.

Special Topics/HON Course Offerings

- **SSGE 295 : Researching the City (SS)** – *Approved with Suggestion*
Discussion: This new Special Topics course was presented by Behler. Instructor Christian Doll was present. Reviewer complimented the evaluation methods. Suggestion regarding Objective 1 - suggestion to change “resident experience” to be related to how the resident experience is related to human experience/behavior.

Discussion: **USDEI Review**

Marta shared the Provost’s charge to review the USDEI GEP Category, specifically the name and the objectives, with an implementation timeline for Fall 2025. Helen and Herle shared some initial conversations and questions, and Charles and Li offered information Concerns pertaining to implementation and timeline. The committee discussed the process of GEP Review and alteration and that broad feedback would be needed from the campus community. The Chair and OUCCAS

suggested following a similar procedure to FAD, such as using Google Forms for feedback, and establishing an ad-hoc committee to set up questions and resources to enable members to reach out to their constituent groups, including reaching out to the Student Senate and Faculty Senate during the feedback phase of discussion. A motion was made to put together an ad-hoc committee of CUE to review the charge as set forward by the Provost and formulate a considered and thoughtful response. Motion was seconded and passed unanimously. After confirming ad-hoc members, the meeting was adjourned.
