1. Welcome and Introductions

The meeting was called to order at 2:05 p.m. It was determined that a quorum was present.

2. Update on admissions

Tommy Griffin reported on the current status of applications. Freshmen applications were up 13% and transfer applications were up 10% compared to last year. Offers were made to target a goal of 4,490 students for the freshmen class. Deadline for reply is May 1.

There was discussion of spring connection students. These are the students who began their undergraduate program during the spring semester. These students have some challenges as a result of beginning their programs in the spring. For example, course scheduling might not be ideal in some cases.

There was also discussion of a new program – Community College Collaborative. The students in this program will have dual admission. They will begin their program at the community college and complete it at NC State.

3. Discussion of outcomes for students with multiple suspensions

Charles Clift presented data showing outcomes for suspended students after their first semester as a returning student. There was discussion of the data as well as suggestions for other ways to look at the outcomes for previously suspended students.

4. Discussion of changes on the website for the appeals roster

Jordie Batts described recent changes in the website. The number of votes for each appeal is visible; however, the individual votes are no longer visible. Jordie and others in registration and records will try to review the roster regularly and remove any appeals that have 2 votes in agreement. This will prevent requiring a third vote on all appeals.

5. Timeline for end of term appeals in May

Jordie Batts indicated students will be notified on May 12 of their standing. The deadline for appeals is May 14 at midnight and decisions are due May 15 by close of business. We will maintain 3 teams to review appeals.

6. Rolling appeals in summer

Jordie Batts listed the Summer 2 appeal deadline of June 21 and decision date of June 22. Appeals are already coming in for summer 2 and fall. Committee members are encouraged to view the appeals roster periodically to continually process the appeals.


7. Elect new chair
