## **REVIEW of CURRENT ADMISSIONS PROCEDURES**

- Use of Race in Admissions:
  - NC State University currently uses race as one factor in a holistic application review process. After reviewing that process and the goals of the university with respect to diversity, the Admissions Committee voted at the April 15, 2020 meeting to endorse NC State's continued use of race as one of many components considered in a holistic application review process because we do not feel that we've reached a critical mass across all demographics to allow constituents to feel comfortable and represented on campus and we have no better means of addressing that problem.
- Use of Campus Scholarships in Admissions:
  - NC State University currently uses UNC Campus Scholarships as part of the recruiting process. After reviewing the Purpose, Eligibility, Selection Criteria and Award process for NC State's current use of the UNC Campus Scholarships, the Admissions Committee voted on April 23, 2020 to endorse NC State's current Purpose, Eligibility, Selection Criteria and Award process for the use of the UNC Campus Scholarships as part of the recruitment process. The Committee did not recommend any changes to the current process.

## SUMMARY OF DISCUSSION ITEMS/ACTIVITIES OF COMMITTEE

## • Consideration of Readmission Applications

The main responsibility of the Admissions Committee is the consideration of readmission applications for suspended students. With the current online appeal and review process, the following were outcomes of the committee's deliberations:

The committee voted on April 15, 2020 to waive the application fee for current active duty military personnel. This change is implemented for the Spring/Fall 2021 application cycle.
