Welcome by Tamah Morant

Review of minutes from November 30, 2021 meeting. Minutes approved unanimously.

Introduction and welcome to Katie Cartmell, Director of Advising Technology.

Old Business focused on overall support of readmitted students, consideration of the demographic profile of suspended and readmitted students and reorientation for readmitted students.

Charles Clift shared a slide deck sharing a December 13, 2021 snap shot of suspension data for the fall 2021.

Questions/requests:

- Raw data shows higher percentages of BIPOC identifying students receiving suspension (#students in demog pop suspended / #enrolled students in demog pop) as compared to white identifying students
- Request to see similar data for readmissions
- Request to see if advisor feedback varies by race/ethnicity
- Request for data regarding multiple suspensions

Concerns/Reiterations:

- Concerns around mental health and verifying that students are getting the support they need
- Access to advising and other support during COVID; how has this affected student ability to get advisor feedback (practically) and advisor support (generally)

- Response to comments included in appeals; how can we respond to concerning information
- Cultural differences that may impact suspension (elder care, family support, etc)

Overview of the process at another institution (Katie Cartmell's experience at UNC)

- Advisor-staffed readmissions committee
- Small reading group that reviews all appeals: review group is also the support group for readmitted students
- More centralized advising model
- Optional engagement opportunities for additional student support
- Collaboration with student counseling services for readmitted students
- Restricted enrollment for readmitted students

Suspension and Appeal Data for Spring 2022 (Jordie Batts)

- 184 appeals (164 suspended at the end of fall 2021)
- 141/164 approved (86%)
- 20 readmits (1 or more semesters off): 85% approved for readmission

The readmission subcommittee will meet prior to next meeting to begin the process of gathering college-level information regarding support of readmitted students.
