Approval of <u>prior meeting minutes</u>. Minutes approved unanimously following minor corrections, immediately made

Old Business focused on reporting from and discussion with the Reorientation Subcommittee's work.

- The subcommittee shared an initial draft of a proposal for orientation support for readmitted students. The draft was positively received with suggestions made around:
 - Ownership of the orientation development and execution
 - Assessment of effectiveness
 - Need for additional supporting data to motivate the proposal
- Additional conversation around the process of presenting the proposal/recommendation to the Provost
- Discussion outcomes:
 - The proposal would be expanded and redrafted to address the bullet points above
 - The new draft would be included in the Admission Committee's Annual Report and presented to the Provost
 - The new draft proposal would be developed with a goal of seeing action take place as soon as possible, potentially in time to support students admitted in the fall.
