2. Recommendation for recovery of suspended students

A short presentation was given by Victoria Silvestri. She described the need to connect early with suspended students who are approved to continue and the impact of USC 111, Strategies for College Success, on student success. Currently Victoria teaches 2 sections of this course (15 students per section). The number of students suspended in December was 273. Data presented supported a positive impact of USC 111 on GPA and eligibility to continue for this group of students.

Discussion included ways to encourage students to enroll in USC 111, availability of the course online, the possibility of this or a similar course counting toward the GEP category requirements, and the need for additional data describing outcomes for suspended students. Personnel from the registrar's office will summarize data describing outcomes for students with multiple suspensions. These data will be used for further discussion.

3. Discussion of current appeals organization

General consensus was that the current system of reviewing appeals is working well. The committee is divided into teams. Each team is responsible for a group of appeals in a designated alphabetical grouping. Two votes are needed if the votes are in agreement. A third vote is needed to break a tie.

4. Timeline for review of appeals in Dec/Jan

There are two deadlines. First deadline: Appeals submitted by Wed. Dec. 20 should be reviewed by Friday, Dec. 22. Second deadline: Appeals submitted by Jan. 4 should be reviewed by Friday, Jan. 5. Discussed number of committee members available to review appeals over this interval.
