- 1. NC Institute for Climate Studies (NCICS), Strategic Lease Request #22-03
  - a. Description: NCICS, an UNC system inter-institutional research institute, is a partnership between academic universities, the private sector, non-profit organizations, community groups, and the federal government focused on advancing understanding of the current and future state of the climate. NCICS, a unit within the Office of Research and Innovation, has been leasing space at the Veach-Baley Federal building in downtown Asheville, NC since July 2012. They request to extend the term of the existing lease for an additional 5-year period. If not renewed, the existing lease will expire June 30, 2022.
  - b. **Strategic Lease Requirements:** This space is a strategic lease acquisition in order for the program to be co-located with its prime sponsor, NOAA's National Centers for Environmental Information.
  - c. **Square Feet**: 7901.52 rentable square feet
  - d. **Lease Terms**: Rent rate during renewal term shall be \$28.13/rsf (\$18,529.51/month)
  - e. **Funding Source**: 100% F&A generated by sponsored contract and grant expenses (WRS 257342)
  - f. **Duration**: 5 year extension through June 30, 2027
  - g. **Timing**: Lease extension should be executed before June 2022
  - h. Other: NCSU Board of Trustee approval will be needed
